Drawing of fixtures for the successful conduct of National / Inter Zonal / Zonal University Games with effect from 2015-16 onwards

a. The date of drawing fixtures for National / Zonal University Games shall be fixed at least one month (30 days) before the commencement of competition(s). While drawing the fixtures, all participating universities should be invited, after fixing the date(s), venue for drawing the fixtures. The dates of drawing fixtures shall be considered as the "Last date of receiving Entries" by the host university. Hence, no entries shall be accepted / entertained, after the closing date, except in exceptional circumstance which are beyond human control. The host university may consider such cases on humanitarian ground in the larger interest of university sports.

b. In individual sports like Boxing, Wrestling, Judo, Taekwondo etc., where fixtures are drawn after weighing-in, the fixtures must be drawn in the presence of representatives of the participating universities in accordance with rules and regulations of concerned National Sports Federation.

c. In sports like Kayaking, Canoeing, Rowing, Yachting, Cycling Athletics, Archery, Fencing etc., fixtures / heats may be drawn in the manager's meeting (which is normally held one day before commencement of the tournament) in the presence of the representatives of the participating universities as per rules and regulations of concerned National Sports Federation.

d. Cricket matches will be played of 50 overs in zonal as well as in All India Inter University Tournaments w.e.f.2015-16.

e. In case of team sports, where 16 teams will qualify for participation in All India Inter University Tournaments, the league and knock-out fixtures will be drawn as under:



III) Fixture for the All India Inter University Teams (Men & Women) Championships



2. It shall be incumbent upon the university holding any of the trophies to send it, at its own cost, to the university organising the zonal Final / Inter Zonal Final, as the case may be, of the next years respective tournament through a personal messenger and this transfer shall be effected well in advance of the date fixed for the respective final match / competition.

3. Every university undertaking to conduct inter university tournament(s) on behalf of the Association of Indian Universities (AIU) shall be responsible for its organisation, supervision and conduct in every aspect, in accordance with latest rules and regulations adopted by the respective National Sports Federation recognized by Ministry of Youth Affairs and Sports, to the satisfaction of all the stake holders.

4. For the tournaments played on zonal basis, it shall be the responsibility of the zonal host university to draw-up the dates of the zonal competition(s) allotted to it in coordination with the date(s) of the commencement of the respective Inter Zonal / National University Games as mentioned in Sports Calendar, so that Zonal teams qualifying for the Inter Zonals are able to reach the venue(s) of Inter Zonals directly and conveniently.

5. The zonal organising universities shall fix-up dates of zonal tournaments allotted to them in close coordination with dates of the Inter Zonals. All the possible efforts should be made to avoid the long gaps between zonal and inter zonal competitions with a view to avoid unnecessary difficulties / harassment faced by the sportspersons of participating universities.

6. The disputes / protest cases received during National / Zonal University Games with effect from 2015-16 within the stipulated of 2 hours of the conclusion of the tournament only, shall be decided by the "Jury of Appeal" including organising secretary of concerned tournament, an international athlete of concerned game / sport appointed by Vice-Chancellor of the host university and AIU observer. The decision(s) on such protests shall be taken, then and there, on the spot, with a view to void undue delay in providing justice to the aggrieved parties.

7. Officiating charges will be charged by the host universities during the National University Games as prescribed and circulated by the Association of Indian Universities vide letter No.S/NUG/2013-14/1069-1463dated: 7th June, 2013.

8. Revised detailed entries for participation of sportspersons may be allowed before the start of competition(s), if submitted within the stipulated period.

9. For successful organisation of National / Zonal university games and to maintain absolute transparency, the host universities of the concerned tournaments shall strictly implement AIU rules. In case of any irregularity, the tournament can be declared null and void by the Jury of Appeal, after following the due/established process.
